- 1. APPROVAL OF AGENDA FOR THE DECEMBER 3, 2024, MEETING AND MINUTES FROM PREVIOUS MEETINGS 11/5 (discussion/action)

 LMC: Council has started to review recommendations from Participatory Governance Task group and will continue to discuss. Council also approved reassignment contracts and are now waiting for District HR approval.

CCC: Council discussed the Box 2 prioritization process (see notes from last meeting). Decision was made to throw out proposals submitted by managers w/o discussions or approval of. Senate passed a resolution reaffirming role of faculty in writing requests for faculty hires and requests that Dept. Chair signature be included on request form. All College Day – guideline for implementation of flex calendar seems to suggest that content of flex activities should be vetted (or approved) by faculty. Meetings taking place to discuss. VPEI joined senate and shared 928 and 1111 fund spending plans. Council members want to ensure transparency in expenditure planning and avoid a "free for all" approach to funds.

DVC: At its November meetings, the DVC Senate Council discussed the need for faculty to include guidance language in their course syllabi starting in Spring '25 that outlines their expectations for if and how AI is to be used in their courses. Council members reviewed and approved a process and timeline for the Spring '25 Faculty Lecturer application and also heard a presentation about a Chatbot that has been designed to answer questions about the 4CD Flex obligations and processes. Council reviewed and discussed proposed revisions to DVC procedures and voted unanimously to approve a resolution from SLOAC/Curriculum to address courses that have not been offered and therefore assessed in the last two years.

The DVC Senate also approved a memo from our articulation officer outlining changes required by the college to update current GE approval policies, as well as align its local

general education areas to the updated Title 5 GE definitions, in response to AB 928 and changes to Title 5.

Concerns regarding marketing plan to inform students about course # and GE-related changes. Who is coordinating this?

LMC uses a form for faculty to submit hours (for OAS). Management joined Ac. Senate and shared expenditure plans. People have forgotten about the corresponding program changes. Last Curriculum meeting approved first 7 CCN courses (including two versions of an English course)

7. COLLEGE EDUCATIONAL PLANNING REPORTS – COLLEGE DEVELOPMENT AND COMMUNICATION PROCESSES (information/discussion; action may be taken)

Discussion around how involved senates and/or leaders should be in the development processes at their colleges. Segade requests enough time to consult with departments that are being considered for "in trouble" list. What criteria are being used by each college to identify at risk/in trouble programs?

FSCC requests that college Academic Senate leaders be consulted as the Ed Planning reports are being developed, are involved in determination of "at risk" programs at least one month prior to report being finalized, and that responsible administrators present and get feedback about reports from their respective local senates prior to report presentation at the district level.

How does district define "in trouble" and what parameters are being used to screen for or place programs on list? (CI4008)

We will discuss further at our January meeting.

8. DRAFT AI CODE OF CONDUCT LANGUAGE (information/discussion; action may be taken).

Reviewed draft language and concern over "acknowledgement" and "substantially".

Freytag updated FSCC about conversations had since Consultation Council last week. Focus will be on getting data from eLUMEN and

10. USE/MODERATION OF ALL FACULTY EMAIL DISTRIBUTION LISTS (information/discussion; action may be taken)

Discussed CCC faculty member being put on leave for using all faculty email lists inappropriately. District did not consult with department chair about finding subs for classes. Chairs should be consulted about staffing choices based on bylaws and UF contract language. Plenty of examples from the past where others have used all district/college lists to support various political issues (George Floyd, Ukraine, for example).

Email management/moderation is not 10+1 nor is it in the best interest of faculty/senate representation and dialogue for senate or UF leaders to be policing all faculty email lists. FSCC was unanimous in being opposed to Senate leaders being involved in moderation of email lists or creation or oversight of an internal or external discussion board site.
