Governing Board Meeting of December 16, 2024

The Contra Costa Community College District (4CD) Governing Board conducted a regular meeting on Monday, December 16, 2024, beginning at 5:00 p.m., followed by closed session, and continuation of public session at 6:00 p.m.

Administration of Oath of Office and Annual Organizational Meeting

After they were administered the Oath of Office, the Governing Board welcomed new member Diana Honig (Ward 2) and incumbent Fernando Sandoval (Ward 5). The annual organizational meeting was held, and the following slate of officers was selected for December 2024 to December 2025:

Purchasing Agreements

Among agreements approved, the Governing Board approved the new agreements listed below.

- Diablo Valley College (DVC) will work with the Mount Diablo Unified School District to provide reimbursement for instructors of the Dual Enrollment Program;
- Contra Costa Health Services will provide sexually transmitted infection testing and an education program Districtwide; and
- food recovery services will be provided at Los Medanos College (LMC) as it relates to California Senate Bill 1383.

College Out-of-State Field Trips

The Governing Board approved travel costs for five out-of-state field trips Districtwide, which cover a variety of topics. Contra Costa College students will participate in musical and NASA High Power Rocket competitions; DVC students will enter a speech and debate competition and tour various college campuses around Washington, D.C.; and LMC students will attend a national student advocacy conference.

Governing Board and Academic Calendars

Approval was given for 2025-26 and 2026-27 Governing Board meeting dates. The 2026-27 Academic Calendar was also approved.

Tentative Agreement between 4CD and United Faculty (UF)

The Governing Board gave approval to this Agreement, which was ratified by a majority of voting members. It is the result of negotiations between 4CD and UF to close collective bargaining for 2024-25.
