## Governing Board Meeting of March 12, 2025

The Contra Costa Community College District (4CD) Governing Board conducted a regular meeting on Wednesday, March 12, 2025, beginning at 5:00 p.m., followed by closed session, and continuation of public session at 6:00 p.m.

### Districtwide Student Equity and Achievement Plan Updates

The Governing Board received an update from each college about their 2022-2025 Student Equity and Achievement Plan, including impactful strategies and lessons learned. Each college's plan targets specific student populations, underscoring that this is both data-driven, and people-driven work, which requires resources to advance 4CD's efforts to foster equity and social justice.

### Report on Distance Education and Artificial Intelligence (AI)

The Governing Board heard a special report about the state of distance education at 4CD, highlighting enrollment trends and ongoing initiatives that support equitable and high-quality online teaching and learning. The presentation also featured an update on the 4CD AI Taskforce, outlining progress made over the last year. The 4CD AI Summit will be held on April 11, 2025, at DVC.

### Partnerships Approved for College and Career Access Pathways (CCAP)

The Governing Board amended CCC's CCAP Partnership Agreements with two school districts to include new courses and the addition of one new high school, Sylvester Greenwood Academy, in Richmond. The other schools include Griffin Technology Academy/Mare Island Technology Academy and Hercules High School, which will offer information technology courses as well as broad-based Intersegmental General Education Transfer Curriculum.

### Women's History Month Resolution

The Governing Board approved Resolution No. 21A declaring March as Women's History Month. The 2025 National Women's History theme is entitled, "Moving Forward Together! Women Educating & Inspiring Generations," and focuses on past and present women who have influenced and inspired others by dedicating their lives to education, mentorship, and leadership.

### American Red Cross Month Resolution

The Governing Board approved Resolution No. 21B declaring March 2025 as American Red Cross Month, celebrating the organization's achievements in Contra Costa County in 2024. Its 982 volunteers held 520 blood drives and collected more than 17,356 units of blood, helped 463 military members and their families, and trained more than 1,876 people in vital skills, including first aid and CPR, to help others survive medical emergencies.

The meeting was adjourned in memory of Chris Nickel, DVC adjunct art professor.
