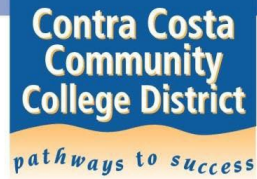


Chancellor's CABINET HIGHLIGHTS

Continued Support for Vulnerable Populations

Cabinet discussed ways for campus administrators, faculty, and staff to assist and reassure vulnerable student populations, who may be feeling fearful following anti-immigration rhetoric by federal authorities and increased efforts to deport undocumented residents.

Strategic Plan Update

Cabinet was introduced to Z Reisz, Senior Dean of Planning and Research, who is assisting with the 2025-30 Strategic Plan. The team working on this project provided an update, indicating that they had received valuable input from students and community stakeholders through forums, and four themes emerged: student-centered; equity and belonging; future-readiness and adaptability; and excellence and integrity.

DVC Lease Project Overview

Facilities consultant Ted Risher of Volz provided an update regarding the Diablo Valley College (DVC) surplus land project. DVC has been working closely with the City of Pleasant Hill to review options to optimize usage of this 10-acre site. Cabinet is considering the best option to increase revenues which will ultimately benefit students, the community and 4CD colleges.

FTES Funding Report

Cabinet received an update regarding historical and current FTES trends. Based on current enrollment, FTES have increased 6.5% over last year. Depending on the Governor's May Revise and P-2 Apportionment Attendance Report, 4CD may reach its Student-Centered Funding Formula (SCFF) funding level for the 2025-26 academic year.

New Business Procedure on Data Classification Standard and Training

Cabinet reviewed language for proposed new Business Procedure 22.22, Data Classification Standard, that would establish a framework for classifying data assets to ensure 4CD is applying the appropriate security protocols to safeguard its information.
